### **Renee Strnad**

I joined the NC State University Extension Forestry team in July 2000 in a newly created position to focus on K-12 youth education; leading our forestry and wildlife 4-H programs, coordinating the

Project Learning Tree program statewide, and supporting other Extension Forestry Team members. I have a B.S. from Kansas State University in Wildlife Biology and second major degree in Natural Resources and Environmental Sciences, also from Kansas State. I was awarded a M.S. from Lesley University in Ecological Teaching and Learning in 2015. Environmental education is where my heart lies, and I especially enjoy facilitating professional development events where participants are challenged to think systemically.

In May 2022, I was approached by an ANREP board member to help manage a multi-year Dissemination Partner Grant from the North American Association for Environmental Education (NAAEE). I had been an ANREP member on and off during my Extension career but was intrigued by an opportunity to bring together the two professional organizations that are the roots of my career. I carry a very broad definition of an environmental educator, and under my definition, many Extension professionals are also environmental educators!
